The Life Cycle Initiative and the Social LC Alliance are glad to announce that a second workshop for the revision of the S-LCA Guidelines will be held in April 24-26th 2019 at the UN Environment office in Paris, France.

The Workshop will consist in two different event

1. Industry Workshop
2. Technical Meeting

The Industry Workshop on 24th April (from 9:00pm to 12:30 pm), will be dedicated to industries and companies – it will be prime occasion to be brought up to date with the process of the revision of the guidelines and to hear about the terms, conditions and benefits in participating in the upcoming roadtesting pilot phase. During that phase, companies/industries will be invited to roadtest the developed Guidelines and thus contribute to their continuous improvement.

The Technical Workshop from 24th April at 1:00pm to 26th April 1:00pm will provide a second opportunity for a face-to-face meeting for members of the S-LCA community involved – or wanting to get involved – in the update of the 2009 UNEP-SETAC Guidelines. The work will focus on discussing key issues to be resolved in the second draft of the Guidelines. All contributors are welcome!

Preparatory work prior to the Technical Workshop for the S-LCA community

A second draft of the Guidelines will be circulated for comments to all interested contributors in the S-LCA community early March 2019. The key issues to be discussed at the April Paris meeting will be determined on the basis of the comments that will be received on this draft. The commenting period will last 1 month, until April 2nd. All contributors – whether they aim to participate in the Paris workshop or not – are encouraged to provide comments, in order to contribute to shaping the workshop agenda.
